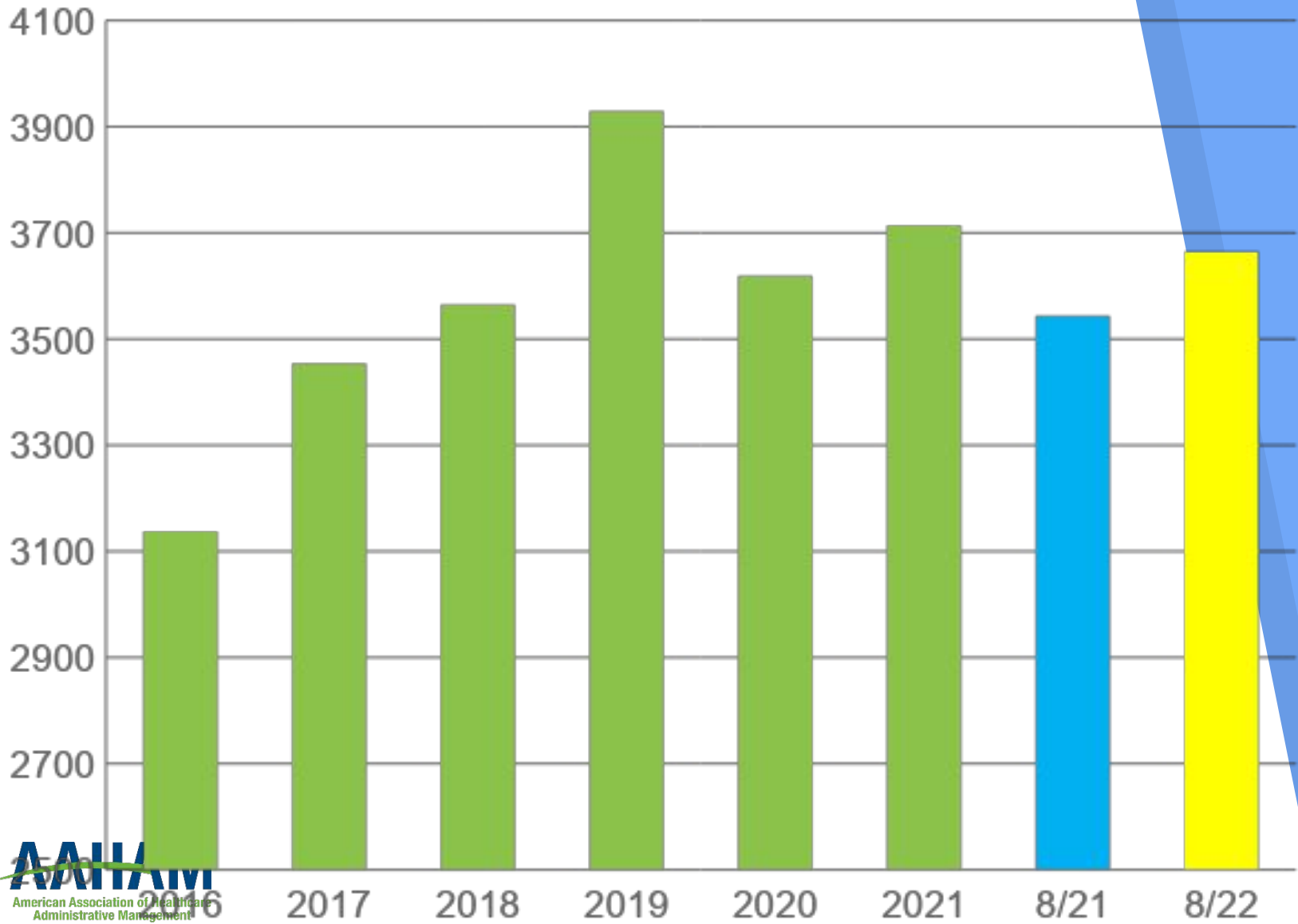

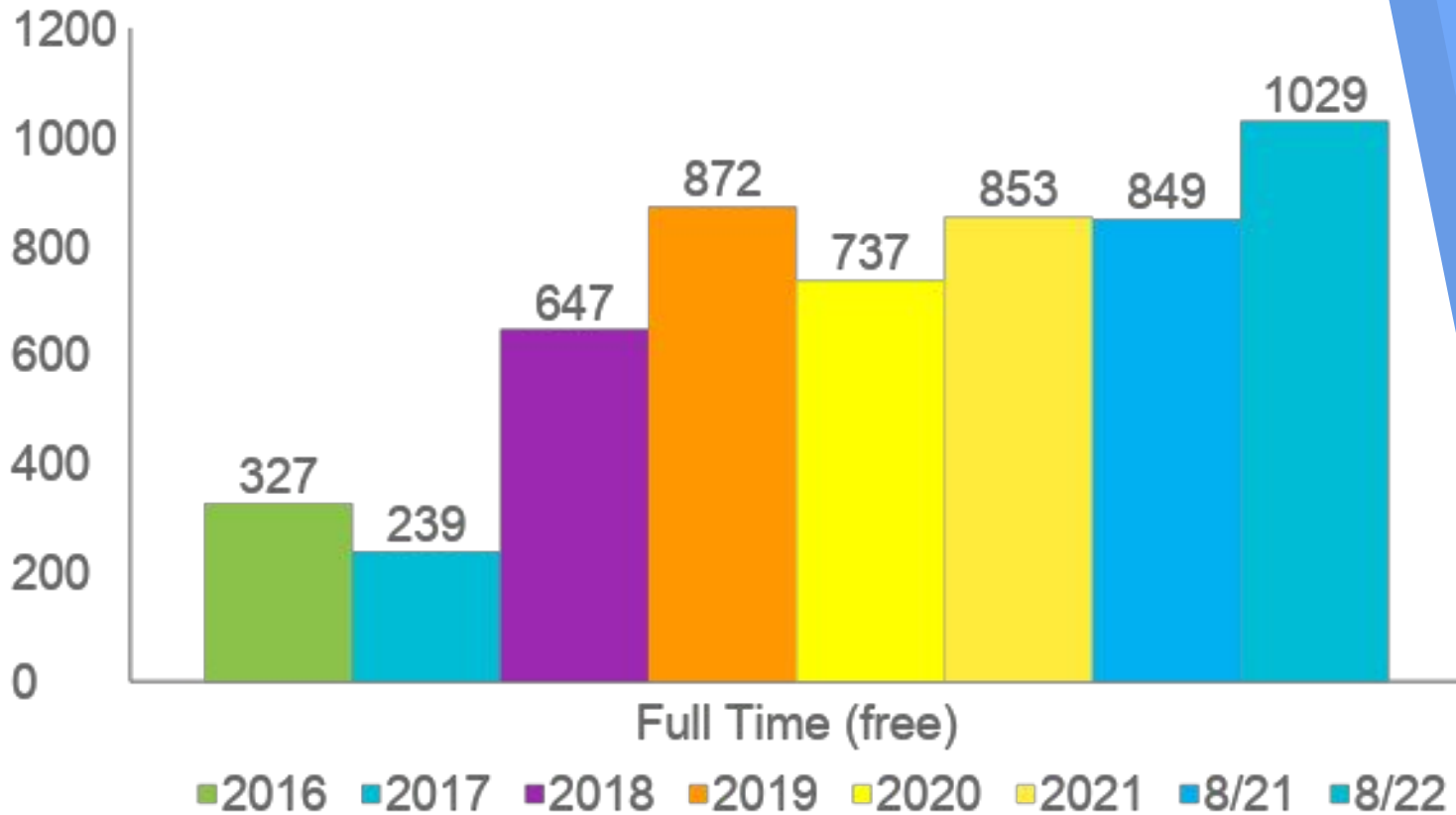

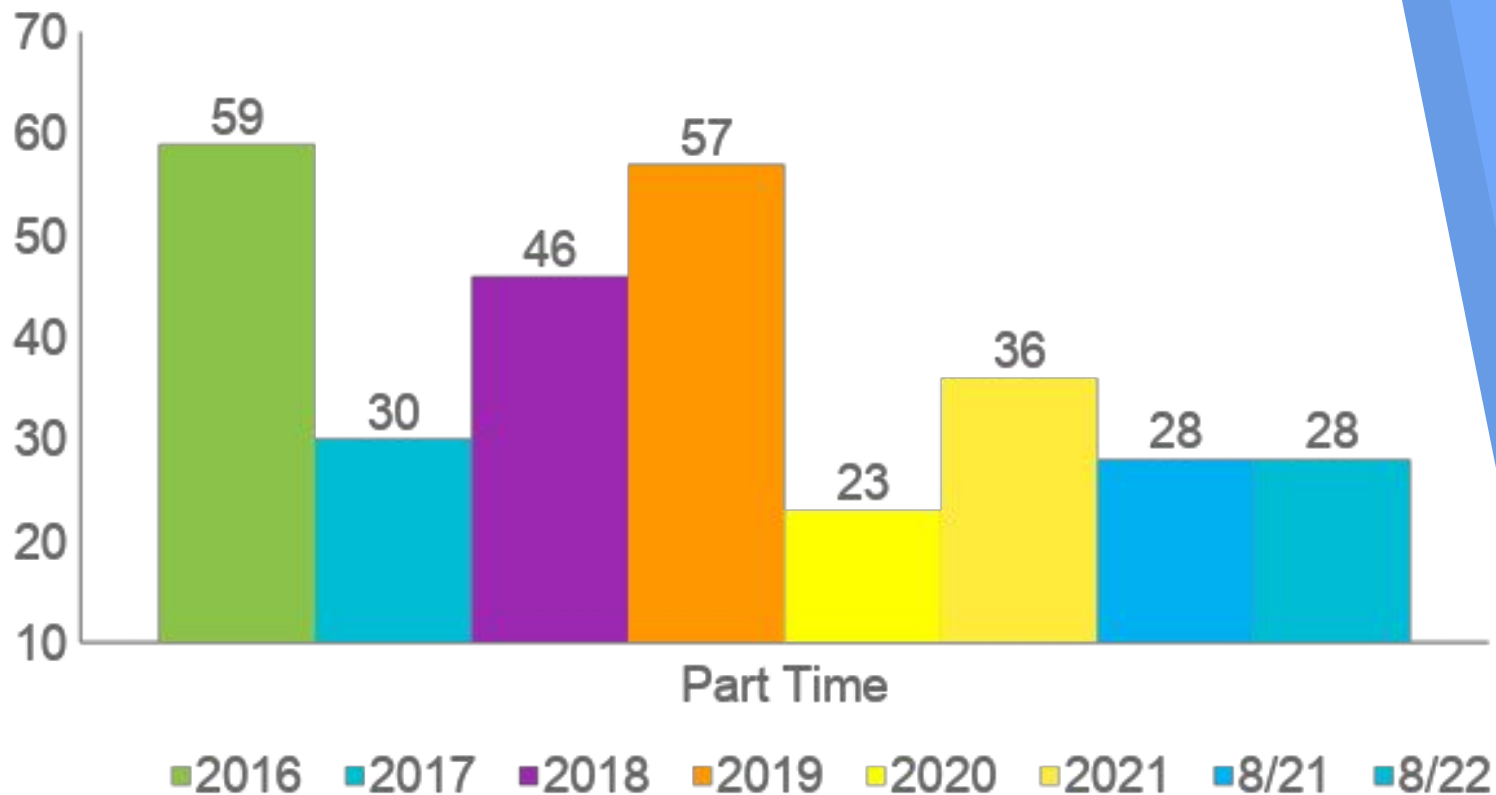
Membership Totals



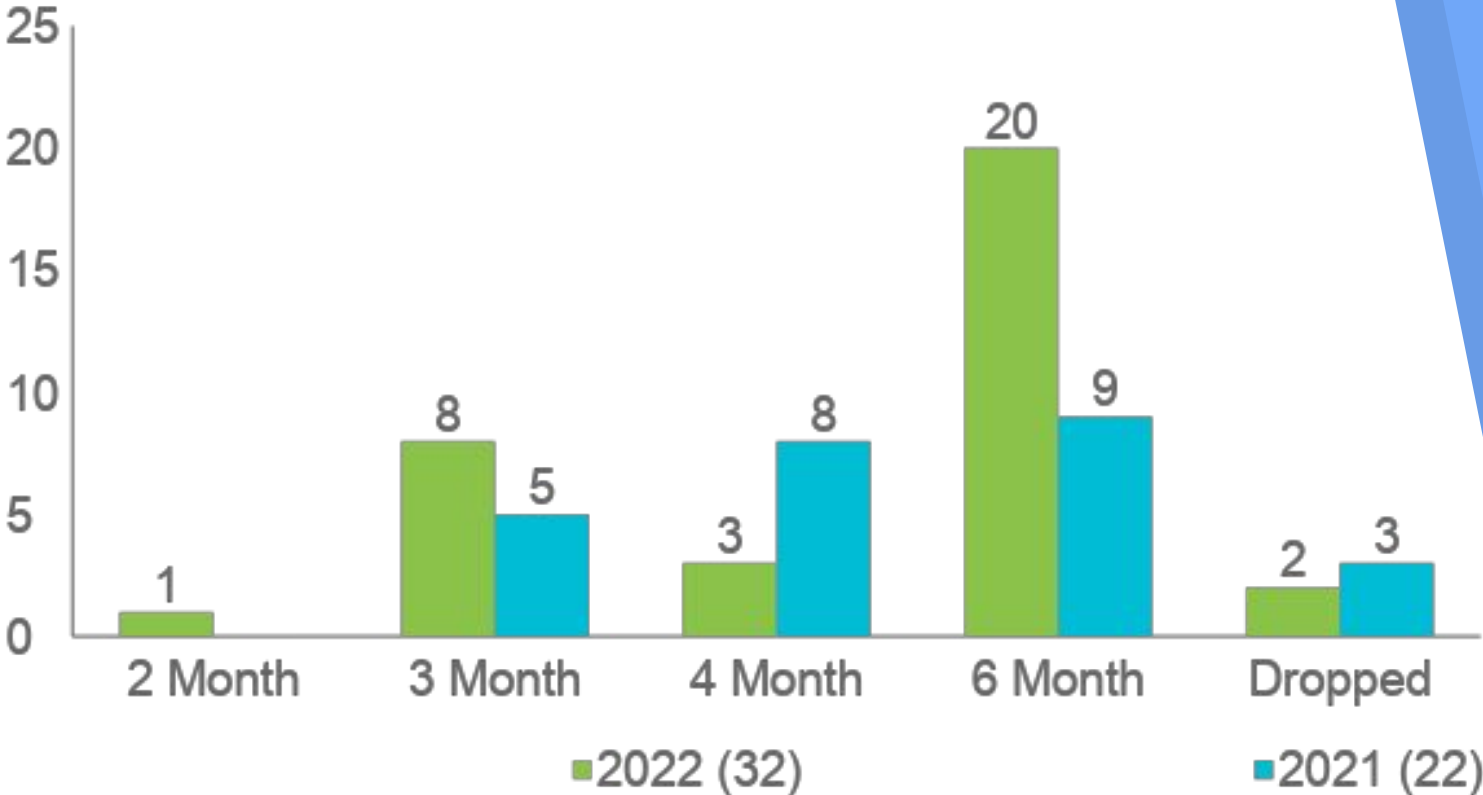
Full-Time Student Members

Members who took advantage of the Payment Plan

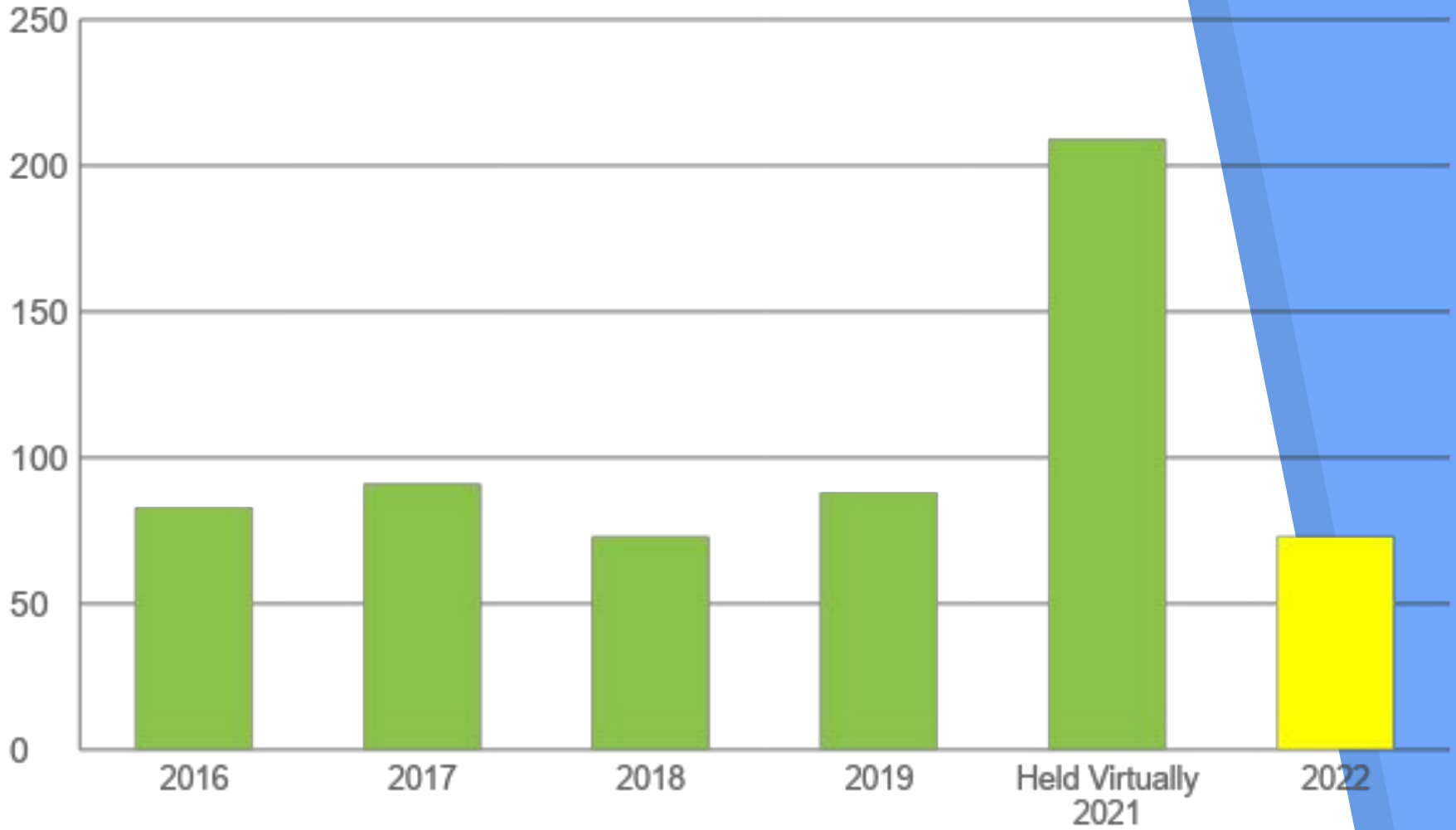

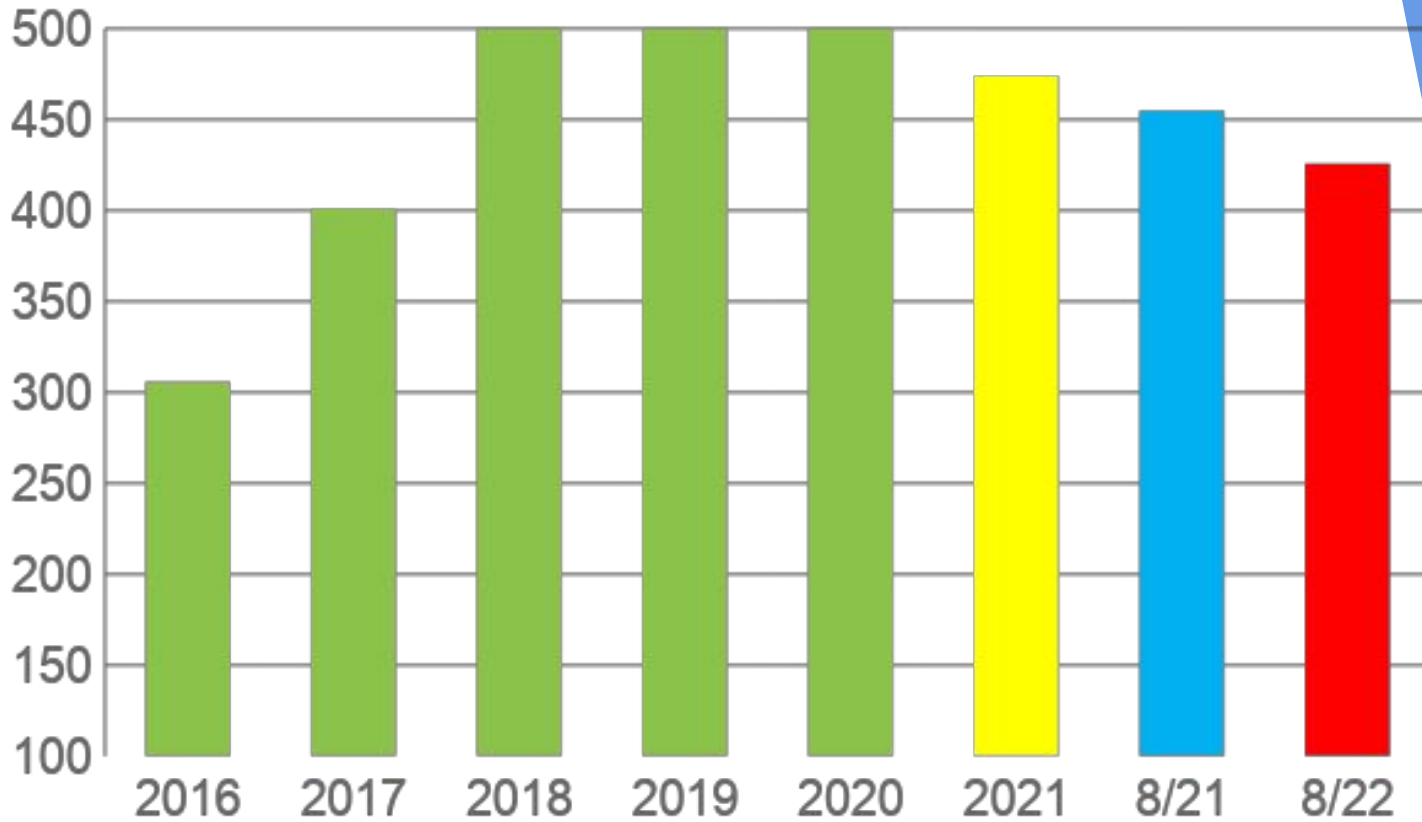

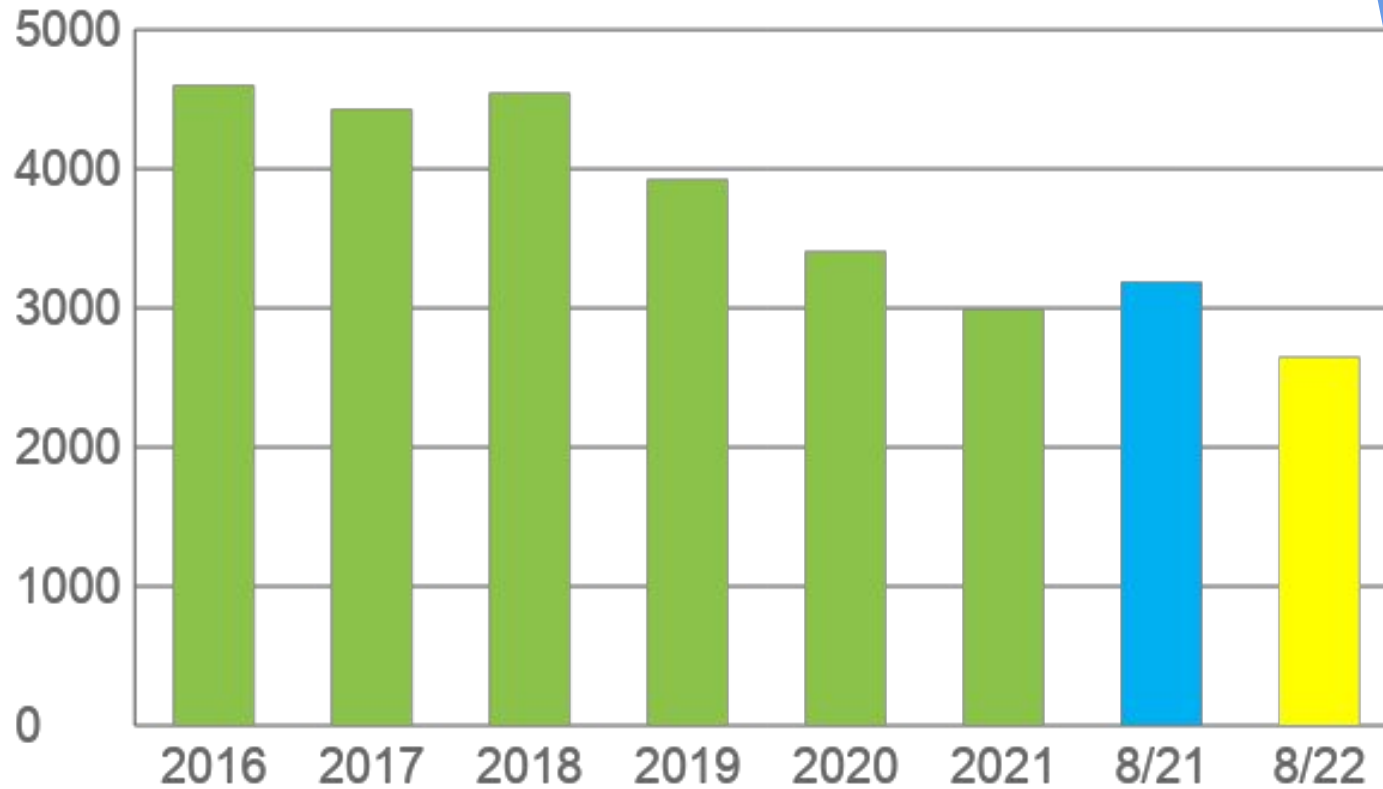
Total CRCP



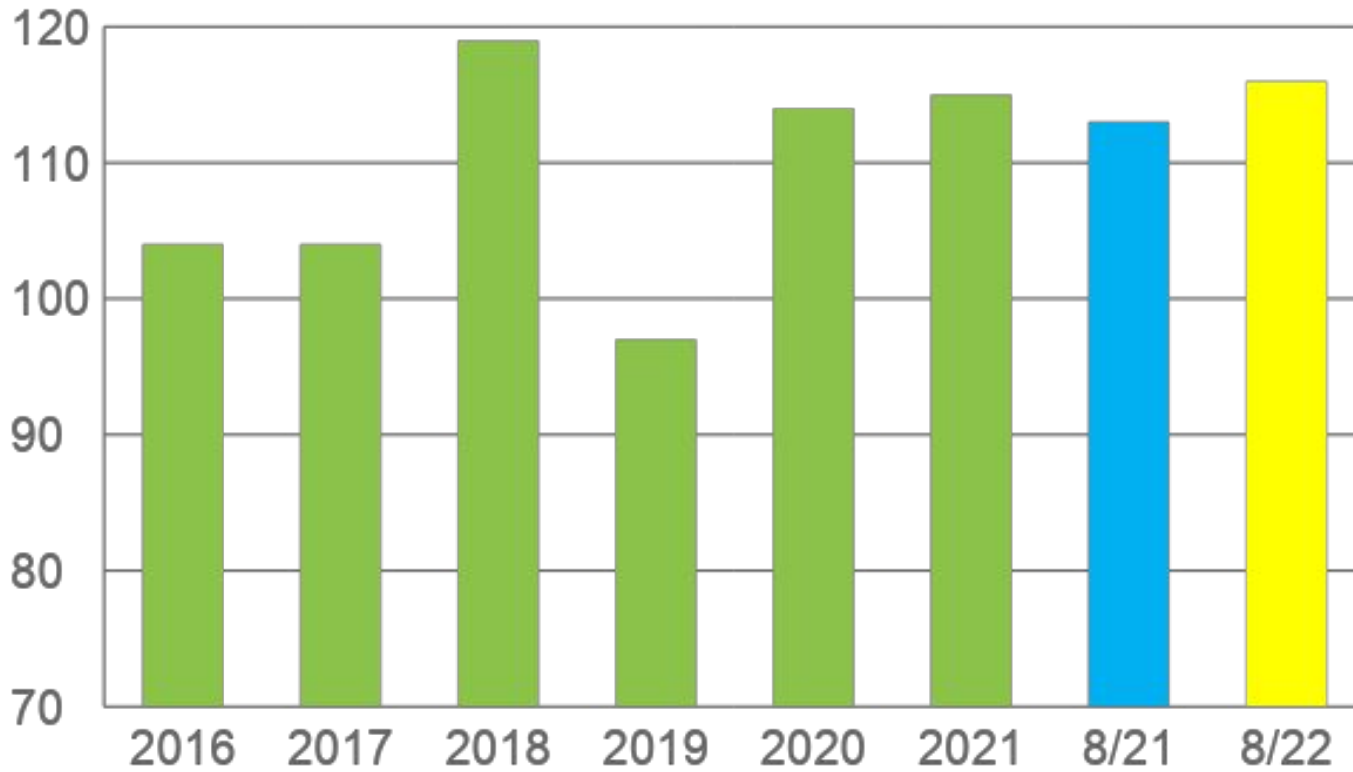
